

**Directions for Use:**

- Begin with clean, dry skin. Apply Cutting Gel one to two times daily. Do not exceed two applications per 24-hour period.
- Focus on one targeted area at a time (i.e., tummy, thighs, etc.) until you achieve desired results.
- Use sparingly. An amount equal in size to a small marble should be sufficient to cover your entire abdominal region or the back of one thigh.
- Vigorously rub Cutting Gel into the target area until completely absorbed.

**Note:** As Cutting Gel begins to work within your chosen target area, you may experience a moderate cooling feeling... this is normal.
